TERSICOREA information for the treatment of personal data (Art. 13 of Legislative Decree 196/2003 - Privacy Code - Art. 13 of the Regulation EU General on the protection of personal data n. 679/2016)

1. The personal data [specify: personal data, contact details, etc.], supplied by you will be processed for the following purposes based on your consent and on the legitimate interest of the writer: The personal data collected (surname and name, residence, domicile, tax code, certified e-mail address and e-mail address, telephone number will be processed within the limits strictly necessary for the fulfillment of the obligations covered by this procedure, and more precisely in relation to the activity relating to the call for choreographic composition "Cortoinanza"
2. Legal basis for this operation are art. 36 of the Civil Code, the tax legislation relating to non- commercial entities, in particular art. 148 of the T.U.I.R. Article. 4 of the Presidential Decree 633/72 and art. 90 of Law 289/2002
3. The legitimate interests of the data controller pursued with this activity are a clear and correct application of the statutory provisions on the internal organization and administration of the association;
4. The treatment will be carried out in the following ways: on manual cards, also made with the aid of electronic means, stored in closed places, the key of which is held by the President and by those in charge of administration, or in a computerized manner, on a PC placed at the headquarters of the Association which is adequately equipped against IT risks (firewall, antivirus, periodic data backup); authorized to access these data are the president and the people in charge of the administration. Pursuant to art. 4 no. 2 of the G.D.P.R, the processing of personal data may consist of the collection, registration, organization, consultation, processing, modification, selection, extraction, comparison, use, interconnection, blocking, communication, cancellation and destruction of data.
5. Personal data will be kept for as long as necessary. The verification of the obsolescence of the data being processed with respect to the purposes for which it was collected and processed is carried out periodically.
6. The provision of data is mandatory for the achievement of the purposes of this announcement and is therefore essential for the acceptance of your application for admission to the same. Any refusal to supply them makes it impossible to accept your application;
7. The personal data may be communicated to the bodies belonging to the Artistic Commission as owners of exhibitions / festivals / artistic residences / workshops and training courses and in the exclusive interest of the candidate to guarantee support for mobility; circuitry of the works and artists involved.
8. The treatment will not concern personal data included in the category of "sensitive" data, ie "personal data suitable to reveal racial and ethnic origin, religious, philosophical or other beliefs, political opinions, adherence to parties, unions, associations or organizations of a religious, philosophical, political or trade union nature, as well as personal data suitable for revealing the state of health and sexual life;

At any time you can exercise your rights to know the data concerning you, to know how they were acquired, to check if they are accurate, complete, updated and well kept, to receive the data in a structured format, commonly used and readable by automatic device, to revoke any consent given in relation to the processing of your data at any time and to oppose, in whole or in part, the use of the same as enshrined in articles from 15 to 20 of the G.D.P.R. 12. You have the right to withdraw consent at any time without prejudice to the lawfulness of the treatment based on the consent given before the revocation. This right can be exercised by sending the revocation of consent to the e-mail address indicated in the previous point 10.
13. You have the right to lodge a complaint with the Guarantor for the protection of personal data or with the different supervisory authority that should be established by the Decree of the Community Law n. 163/2017
14. There is no automated decision-making process, nor any profiling activity referred to in Article 22, paragraphs 1 and 4 of the G.D.P.R.
